Release, Waiver and Indemnification Agreement

This is fully intended to be a legally binding contract. Read carefully before signing. Warning: By signing this agreement you are agreeing to waive certain rights including the right to sue on behalf of yourself and/or your child, and indemnify any party in the event you/child brings legal action.

For all members, adult and infant:

In consideration of receiving permission to enter upon from time to time property or premises used by the BC Competitive Trail Riders Association (BCCTRA) and in further consideration of receiving permission either as a rider or volunteer or in any other capacity to participate in any equestrian activity whatsoever, including without limiting the generality of the forgoing competitive trail rides or practices in or on the Premises, I hereby RELEASE and agree to SAVE HARMLESS AND KEEP INDEMNIFIED BCCTRA, an/or the owners or lessees of the Premises and all of their respective directors, officers, organizers, agents, servants and representatives (the "Releases") from and against all claims, actions, costs and expenses and demands in respect to death, injury, loss, damage, loss of employment, economic loss and future loss of income to person or property that I may suffer howsoever caused, arising out of or in connection with any activity on the Premises and NOTWITHSTANDING THAT THE SAME MAY HAVE BEEN CONTRIBUTED TO OR OCCASIONED BY THE NEGLIGENCE OF THE RELEASES. I FURTHER ACCEPT RESPONSIBILITY FOR THE SAFETY OF MY GUESTS, EMPLOYEES OR ANY OTHER PERSON OR PERSONS RECEIVING PERMISSION TO ENTER UPON THE PREMISES AS MY GUESTS, EMPLOYEES OR IN ANY OTHER CAPACITY WHILE THEY ARE ON SAID PROPERTY OR PREMISES AND UNDERTAKE TO SAVE HARMLESS AND KEEP INDEMNIFIED the Releases from and against all claims, actions, costs and expenses and demands in respect to death, injury, loss or damages to any of the said persons howsoever caused, arising out of or in connection with any activity on the premises and NOTWITHSTANDING THAT SAME MAY HAVE BEEN CONTRIBUTED TO OR OCCASIONED BY THE NEGLIGENCE OF THE RELEASES. I hereby certify that my horse is not under the influence of any medication as set out in the BCCTRA Rule 3.3. It is hereby recognized that all equine sports involve inherent risk and that no helmet or protective equipment can protect against unforeseeable injury. I hereby accept this risk and hold harmless the Releases. It is understood and agreed that this agreement is to be binding on myself, my heirs, next of kin, executors, administrators and assigns.

WE/I, being the parent(s)/guardian(s) of the above infant under the age of nineteen years, (the participator) do hereby agree that we/I will not commence any legal action on behalf of either the Participator or my/ourselves as against the Releases arising out of any and all liability for any death, loss, damage, injury, expense, property damage, loss of employment, economic loss and future loss of income that I/we or the Participator may suffer as a result of his/her participating as a rider or in any other capacity in any equestrian activity whatsoever including, without limiting the generality of the forgoing, competitive trail rides or any other activities sanctioned or organized by the Releases in or on property or premises owned, occupied or used by the Releases due to any cause whatsoever INCLUDING NEGLIGENCE ON THE PART OF THE RELEASES. We/I, for and in consideration of the Releases permitting the Participator to participate in any of the said activities hereby agree that I/we shall be liable for and fully indemnify and hold harmless the Releases of and from all claims of any nature whatsoever and made by the said Participator that shall arise by, or in any way directly or indirectly be related to, the said Participator participation in any of the said activities. We/I do hereby agree that we/I have read the Release, Waiver and Indemnification Agreement hereto and agree to be legally bound by its terms and conditions as though I/we were the Participator in consideration of allowing the Participator to participate in any of the said activities. It is understood and agreed that this agreement is to be binding on ourselves/myself, our/my heirs, next of kin, executors, administrators and assigns. We/I are/am the full age of nineteen years and have read and understood this agreement before signing it. We/I are/am aware that by signing this agreement, we/I are/am waiving certain legal rights including the rights to sue on our/my behalf of our/my child, the Participator.
